A. INSTRUCTION:

The size from chin to crown for the person in the photograph must be 32mm to 36mm. There must be sufficient headroom with a white background.)

B. BASIC CRITERIA FOR THE APPLICATION

The basic criteria for granting this Equivalent MBST Certificate to eligible members of IOSH(HK) are as follows:-

1. Have paid up the IOSH membership subscription for the current year.
2. Possess membership status of specific ranks, i.e., either Chartered Fellow, Chartered Member, Graduate Member or Technician Member.
3. Have acquired at least 5 CPD hours on subjects related to occupational safety and health within the immediate preceding 12 months before annual renewal of this Equivalent MBST Certificate. The CPD hours can be acquired through talks, seminars and technical visits related to occupational safety and health organized by IOSH(HK).

C. PRINCIPLES AND RULES OF APPROVAL

1. The Equivalent MBST Certificate is issued to eligible member who should possess a Hong Kong Identity Card and make a declaration to confirm that he/she has had at least two years of working experience in Hong Kong at the time of submitting this application.
2. The validity of the Equivalent MBST Certificate is one year counting from the issue date.
3. Each Equivalent MBST Certificate shall be affixed with a recent photo of the cardholder and is non-transferable.
4. The Equivalent MBST Certificate is issued free of charge.
5. The Equivalent MBST Certificate is the property of IOSH(HK).
6. IOSH(HK) has the right to withdraw and to cancel individual Equivalent MBST certificate at its own discretion.

D. LOST CARD PROCEDURE

If the certificate is lost, the cardholder can apply for re-issuing the certificate provided that he/she must submit to our office a duly completed application form together with a confirmation letter issued by the Labour Department regarding the reported loss. An administration fee of HK\$100 will be charged for this re-issue of certificate.
